Important Note: Please read this notice as it constitutes part of your contract with Zara Tours Inc. or Zara Tanzania Adventures. Kindly check your reservation confirmation for errors and contact Zara Tours Inc. if you have any questions or concerns.

In consideration of the services provided by Zara Tours Inc. or Zara Tanzania Adventures (“Tour Operator”), its shareholders, directors, officers, employees, agents, volunteers, participants and all other persons or entities associated with or acting in any capacity on its behalf, I hereby agree to release, indemnify and discharge the Tour Operator on behalf of myself, my heirs, successors, assigns, and for my family, including minor children, for any losses, damages, and causes of action of any kind which arise directly or indirectly from my participation in any trip or activity organized by the Tour Operator as further described herein, and I further confirm as follows:

- I acknowledge that the Tour Operator is acting as a mere agent for suppliers or independent contractors in selling travel-related services, or in accepting reservations or bookings for services that are not directly supplied by this Tour Operator (such as air and ground transportation, accommodations, meals, tours, guide services etc.). The Tour Operator, therefore, shall not be responsible for breach of contract, failure to comply with any laws, or any intentional or negligent actions, omissions, or defaults on the part of such suppliers or independent contractors, which result in any loss, damage, delay, inconvenience or injury to travelers or travelers' companions or group members. I further acknowledge that the Tour Operator has no control over, and I shall not hold the Tour Operator accountable, for the actions of any supplier or contractor involved in providing services on the trip or activity.
- I acknowledge that the Tour Operator does not guarantee any supplier's rates, bookings, reservations, connections, scheduling, or handling of baggage or other personal effects. I assume complete and full responsibility for, and hereby release the agent from, any duty of checking and verifying any and all passport, visa, vaccination, or other entry requirements of each destination, and all safety and security conditions of such destinations, during the length of the proposed travel.
- I acknowledge that the Tour Operator shall not be responsible for any injuries, damages, or losses caused to any traveler in connection with dangers and risks inherent in sporting/adventure activities, climatic conditions, accidents or illness, terrorist acts, mechanical or construction failures or difficulties, social or labor unrest, local laws, abnormal conditions or developments, acts of God, or any other actions, omissions, or conditions outside the Tour Operator or travel agent's control.
- I am aware that, during the trip or activity, I may be subjecting myself to dangers and hazards, which may result in physical or emotional trauma, illness, injury, paralysis, death or damage to myself, property and/or third-parties. I

acknowledge that high-altitude mountain hiking entails known and unanticipated risks including, but not limited to, the hazards of traveling in uneven mountainous terrain and slips and falls, being struck by rock fall, ice fall or other objects dislodged or thrown from above. I further acknowledge the risk of insect bites or animal attacks. I understand that many areas in East Africa are remote without access to medical facilities or rapid evacuation and assistance. I have been warned of the above risks as well as possible travel industry bankruptcies and medical and climatic disruptions, and acknowledge the possibility I may be unable to travel as scheduled because of personal emergency. I understand that this description of risks is not complete and that other unanticipated risks may occur.

- I expressly agree and promise to accept and assume all of the risks associated with this trip or activity whether expected or unexpected. My participation in the trip or activity is purely voluntary, and I elect to participate in spite of the risks.
- I expressly agree to forever release, discharge and indemnify and hold the Tour Operator and its agents, employees, officers, directors, associates, affiliated companies, and subcontractors harmless against any and all liability, actions, causes of action, debts, suits, claims, and demands of any and every kind and nature whatsoever, and I acknowledge that I shall be responsible for all Tour Operator's legal costs as allowable by operation of law, which I now have or which may hereafter arise out of or in connection with my trip or participation in any activities arranged for me by Travel Agent.
- I certify that I have adequate insurance to cover any injury or damage I may directly or indirectly cause, or suffer, while participating or else I agree to bear the costs of such injury or damage myself.
